# CLUB HISTORY



## Skål Ft. Lauderdale & Palm Beaches ... Committed to the principals & goals of Skål International



### 2002:

- Club losing members due to retirement & relocation
- Stymied in efforts to recruit new members due to the changing business environment in the Palm Beach County area
- Travel & Tourism changed with increased use of the internet & consolidation of the airline industry
- Majority of potential new Skål members located in the Ft. Lauderdale area where airlines & cruise lines have regional offices



# CLUB HISTORY



- The need to include Ft. Lauderdale in the name of the Club became apparent
- Recognized need to commit to hosting significant portion of monthly meetings in Ft. Lauderdale area to bring credibility to efforts to attract new members
- Determined not to let the Club gradually decrease in membership to the point of being de-activated
- Decision was made to be pro-active & aggressively pursue the name change



# CLUB HISTORY



## 2006:

- February 2006 approval received to formally change the name of the Club from Skål International Palm Beaches to Skål International Ft. Lauderdale & Palm Beaches
- Following the lengthy process to obtain approval for the name change, we have had tremendous success in building our membership and enabling all of our members to realize the benefits that membership in Skål International has to offer



# CLUB HISTORY



- Holding three meetings a year in the Palm Beach area / three meetings a year in the Ft. Lauderdale area / four meetings a year in the Boca Raton area
  - This program allows our members who are spread between Ft. Lauderdale and Port St. Lucie to attend more meetings
  - Credit card program created to provide our members with more payment options

## 2009:

- Instituted NEW Membership Retention Plan





# MEMBERSHIP



## Maintained Membership

- Rare feat in a year when most USA Clubs had a drop in membership numbers
- Florida ranks 2<sup>nd</sup> among states with the worst economies in the USA
- Ft. Lauderdale & Palm Beach areas unemployment rate ranks considerably higher than the USA average
- Current area unemployment rate = 12.8% vs. USA unemployment rate of 9.4%



# MEMBERSHIP RETENTION



## **NEW / Membership Retention Plan**

- Created & Implemented “Plan of Action” to retain existing membership in a difficult USA economic climate

## **NEW / Membership Retention Fund Created**

- During 2009 – 2010 eleven members were assisted who would have otherwise dropped their membership
